

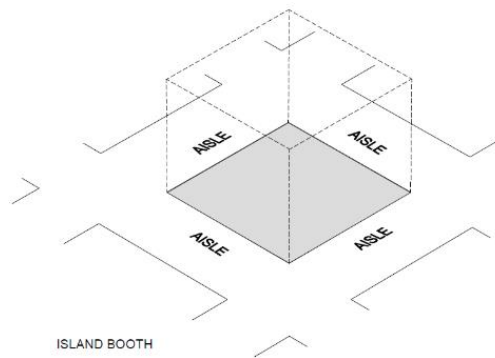

GLOBAL HEALTH CONFERENCE & EXHIBITION

10x20 ISLAND BOOTH

DEFINITION: Ten-foot by 20-foot booth (10' x 20' / 3m x 6m) with aisles surrounding all sides



****NOTE:** All island booth designs must be approved by show management in advance of the show. Please do not go into production on your booth until you have submitted an [Island Booth Submission](#) Form and received approval from show management. All exhibitors with island booths must submit a detailed drawing of the design with a completed booth review form to show management by **January 16, 2026**.

BOOTH PLAN SUBMISSION

Floor plans must be approved by show management prior to going into production. Submit your HIMSS26 island booth floor plan via the [Island Booth Rendering Approval Submission Form](#) no later than **January 16, 2026**.

FINISHED SURFACES

All back walls, side walls or other exposed components of the display must be draped or professionally finished.

HANGING SIGNS

HANGING SIGNS ARE NOT ALLOWED FOR 10' X 20' ISLAND BOOTHS!

HEIGHT LIMITS

The maximum height is 8' (2.44m). Booth presence (including signs/graphics) can be 12' (3.65m) with show management pre-approval.

INTERACTIVE DISPLAYS

If you have any type of interactive display, there must be a 3' clearance from all aisles to allow for crowds.

MULTI-STORY EXHIBITS

MULTI-STORY EXHIBITS ARE NOT ALLOWED FOR 10' X 20' ISLAND BOOTHS!

UTILITY ACCESS

Some booths may contain permanent facility columns with safety equipment and utilities. Facility columns containing fire equipment and utilities require a 36" clearance at all times. Fire safety equipment (extinguishers, hose cabinets, control valves) and permanent fixtures cannot be moved and must remain accessible. Please be sure to clearly identify the facility column in the submission of your booth rendering. If you are unsure that a column is in your booth space, please reach out to exhibitors@himssconference.com

Booths on the perimeter of the exhibit hall are prohibited to utilize the space behind the drape or wall of the booth for storage. Exhibit structures must be constructed to allow for emergency access and utility service at the rear of the booth.

VISUAL OPENINGS

All booths must have at least 25% visual opening on all sides of the booth, so as not to block your exhibiting neighbors. If your booth walls cannot exceed higher than 3 feet tall. Anything higher than 3 ft. must either be clear of walls, open or have clear paneling. Clear paneling may not be tinted, frosted or have graphics adhered to it. Any paneling or glazing of this type is expected to remain clear for the duration of the event- i.e. the use of blinds / curtains is not permitted.
